**The elections will be held  
Sunday, February 14, 2016  
from 9.00 to 19.00**

**TO APPLY AS COUNCILLOR  
you will have to:**

- be a non-EU citizen or stateless*
- not hold Italian citizenship*
- be over 18*
- be resident in the municipality of Vicenza*
- have resided in Italy for at least five years*
- not be in the conditions of incompatibility and ineligibility provided for councilors by law*
- be in possession of a valid residence permit or receipt showing the application for or renewal of residence permit*
- be added to the electoral roll of candidates*

**TO VOTE FOR CANDIDATES  
you will have to:**

- be a non-EU citizen or stateless*
- not hold Italian citizenship*
- be over 18*
- be resident in the town of Vicenza and regularly enrolled at the registry of the City of Vicenza at the date of calling of the election*
- have a valid residence permit or receipt showing the application for or renewal of a residence permit.*
- have regular requirements for residence*

**LISTS of CANDIDATES**

The lists of candidates should include a minimum number of 6 candidates to a maximum of 21.

On ballots neither of the two genders (male and female) can be present in more than two-thirds.

Each list of candidates must be supported by a minimum number of 30 and no more than 80 signatures of non-EU or stateless voters residing in Vicenza

Council members are elected to represent foreign residents coming from the following geographical areas:

- Europe Community and stateless persons,
- Africa
- America
- Asia - Oceania.

Each list may present candidates from one or more geographical areas.
