PRIVACY POLICY PURSUANT TO ARTT. 13 AND 14 OF THE REGULATION EU 2016/679 (GDPR) VIOLATION ASSESSMENT SERVICE

Listed below, are reported information relating to personal data processing, as part of the administrative violation assesment, within the City of Vicenza.

PURPOSE AND METHOD OF THE PROCESSING

Personal data processing is finalized to ascertain violations relating to: Traffic Laws Legislative Decree No. 285/1992 and subsequent amendments, municipal regulations, union ordinances, TULPS (Consolidated law on public safety), Legislative Decree No. 114/1998 (Reform of the regulations relating to the commerce sector), Legislative Decree No. 152/2006 (Environmental regulations) and from all other state and regional laws, when their non compliance implies administrative sanctions by the Local Police, and activities of collection and payment.

The above mentioned processing involves the detection of violator's data both in phase of verification of violations, and collection of additional information relating to the owner of the vehicle to "Pubblico Registro Automobilistico" (PRA), and to other Offices and/or Authorities, and finally during all phases of mailing of contraventions and collecting loss of income.
